

Glue-Sniffing Health Hazard

Parents, teachers, physicians, and law-enforcement officers are becoming increasingly concerned about a new form of juvenile protest which has developed a sizeable number of followers in recent years — glue sniffing.

Like alcoholism and narcotics addiction, glue-sniffing frequently becomes the refuge from an unendurable reality. The habit is indulged in most frequently among boys who come from unstable homes, those who are underdeveloped physically and feel emotionally insecure at a time of life when conformity with peers is most important, and those who are not achieving at school or in their social activities.

THE TOXIC substance most commonly found in plastic cement is toluene, which acts as a depressant on the central nervous system. The major mental response to this substance is a temporary sense of excessive well-being. During this stage, the young addicts have been known to resort to cruel and violent behavior.

Youngsters who have developed the glue-sniffing habit frequently develop leukemia, anemia and other blood disorders, as well as disturbances of the kidneys and liver. Other symptoms which have been reported include headaches, sleepiness, forgetfulness, double vision, loss of weight, numbness, tremors, muscle spasms, and chest pains.

Research is now being planned to find a substitute for toluene and other toxic solvents in plastic cement. Manufacturers of these cements and the hobby industry which promotes their use are cooperating actively with public officials to develop a sound and acceptable solution to this problem.

Until such a time as toxic glue is no longer available, the problem should be approached in terms of the psychological stresses of the young persons who are habituated to glue-sniffing. Psychiatric evaluation and family casework are indicated in such cases.
