able to many climate zones. Your nurseryman stocks only those that grow well in your area, so check his stock now. This is the best time for planting ten-der material, so consider citrus trees, guavas and loquats for planting now.

4. Start feeding azaleas right after they bloom. Ask your nurseryman for an acid fertilizer. Mulch around the plants with peat moss, leaf mold or one of the commercial shredded bark products. Don't bury the crown of the plant with the mulch. Pay careful attention to watering as weather warms up.

5. For color in a hurry, transplant annuals that are ready to bloom into your garden in clumps of three or six. Dwarf marigolds, pansies, dwarf snap-dragons and Iceland poppies, available in flats now, will give almost instant swathes of color when planted this way.
