

# Rich Derby Slated at Alamitos

Los Alamitos Race Course winds up the second week of action Saturday with the nine-race program featuring the \$50,000 Los Alamitos Derby, the richest race that will be staged during the 25-day spring quarter horse meeting.

The 10 fastest qualifiers from last Saturday's Derby Trials, which was run off in three heats, will go in the Derby this week-end. The list is headed by Henry Van Ruiten's Miss Gold Angel, which posted the fastest qualifying mark of 22.30.

The 3-year-old daughter of Three Bars captured the first division of the Trials by a head over Connie Reb whose time was 22.32.

Go Rebel Go, which captured the second division of the Trials, was third among the select group for the Derby by a 22.44 time, while Southern Sea, winner of the third division, ranked eighth among the qualifiers with a 22.57 mark.

The other six horses going to the Derby, which will reward the winning speedster with a \$25,000 first prize are Usage Lamb, Bresa Bar, Cheque Deck, Little Bar, Olene, Sancy Reward and Moore Go.

There were three surprises among those which failed to qualify in the Trials. Rapid Volley finished fifth in the third division and had a clocking of 22.79 and was ranked 19th. Rapid Volley went off a 2-5 heavy choice in the third heat.
