THE CAMPAIGN was sparked again this week when Gray denied to the Press-Herald that his office was responsible for issuing a statement attributed to him and calling the coroner's inquest system a farce.

"No one has been authorized by me to circulate this document. It does not contain my signature or any other person's signature. It does not represent my viewpoint," Gray said in a statement sent to the Press-Herald last night.

HOWEVER, the Press-Herald was informed by several sources that Gray's supporters were passing out texts of the statement in the area, and the text of the statement obtained by the Press-Herald came through the same channels and in the same form as have all of Gray's statements during the campaign.

Considered by most observers to be a major contender for the nomination in the 32nd is Torrance Councilman David K. Lyman. With a heavy Democratic registration in the District, the Democratic nominee should be an odds-on choice to win the seat in November.

Two Lomita Civic Leaders Join Harold Garvin Drive

Harold Garvin, candidate for State Senator, has appointed Dr. Willard Brown and Reverend Eldon Durham as co-chairman of his campaign in Lomita and Harbor City.

The Rev. Mr. Durham, who has served 16 years as minister in Lomita, expressed enthusiasm for Garvin's candidacy, especially his plans to reduce taxes for homeowners and reform election laws.

"President Johnson presented election reform legislation to Congress last week that could have been taken entirely from Harold's speeches," said Durham.

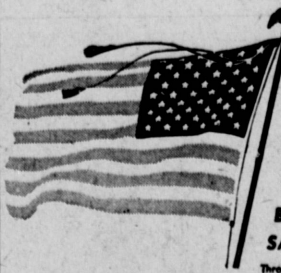
Dr. Brown, who was a candidate for State Superintendent of Public Instruction last election, has served as editor of psychology and political science textbooks for Lippincott and McGraw-Hill Publishing companies.

A political science major at University of Southern California, Dr. Brown is founder and twice president of the local chapter of The American Federation of State, County, and Municipal Em-

ployees Union, AFL-CIO. He has been an official delegate to five state and national AFL-CIO conventions and a lifetime member of the National Education Association.

"I believe Garvin is designed for Senator for our area. He is a leading authority on state government, a lifetime and hardworking democrat, and one of the most ethical and high principled men I have ever known in public life," Dr. Brown said.
