Torrance Elks Schedule Special Flag Day Rites

Plans are underway to make this year's Flag Day observance a "demonstration for America," Ozzie Grimes, Exalted Ruler of the Torrance Elks Lodge No. 1948, announced today.

He said that the lodge was joining the nationwide program led by Elks lodges to show support for democratic institutions and to protest the anti-democratic tactics employed by fanatical extremists in the name of peace.

"All Americans with any sense want peace and that includes just about everybody in this country," Grimes said, "just as they defend the democratic right to dissent, but lawlessness is not dissent."

"WE INTEND to invite all patriotic people of our community to join in a great demonstration for America," Grimes said. "It is time that we who are opposed to destructive violence that threatens the safety and security of our Nation stood up against such tactics by either the left or right. By remaining silent we encourage these extremists on a course that can only lead to the destruction of America if it is not halted."

On Flag Day we are going to speak out against those who preach and practice violence and hatred."

Planning for the Flag Day event on Wednesday, June 15 at Torrance Elks Lodge at 8 p.m. is in the hands of a speaker Past Exalted Ruler Herman Sneskin.

The Elk officials pointed out that Flag Day, June 14 is the 189th anniversary of the birth of the United States Flag. It was on that date in 1777 that the Continental Congress adopted a resolution authorizing the design of the Stars and Stripes as the national ensign.

County Health Department Commended by Supervisors

Commendation for prompt action by the County Health Department in providing immunization during the recent measles outbreak was extended by the Southern California Chapter of the American Academy of Pediatrics and the Los Angeles Pediatric Society, reports Supervisor Kenneth Hahn.

During the outbreak the Health Department quickly provided over 100,000 doses of vaccine to youngsters. Hahn said he was proud of the strong efforts of the Health Department in preventing the outbreak from getting out of hand and becoming a serious hazard to citizens of Los Angeles County.

Dr. Allen W. Mathies Jr., chairman of the Joint Public Health Committee of the two pediatric societies, said that such cooperation between public health authorities and private doctors could well allow achievement of the goal of measles eradication.
