## Handicapped Students Return to Classrooms

Spending the year in a small class geared toward their special needs has enabled 19 students with neurological handicaps or behavior problems to return to regular classrooms next fall.

The students were part of a group of 137 students of normal intelligence who were previously unable to keep up with their classmates.

As a result of participating in special instruction classes, they have not only improved behavior, but have made tremendous academic strides, according to a recent report to the Board of Education.
