The Lutheran Women's Missionary League (LWML) at Ascension has 100 active members. Twelve of them are singing in the LWML Chorus at the convention.

Others will be taking part in selective activities and panels as the convention proceeds.

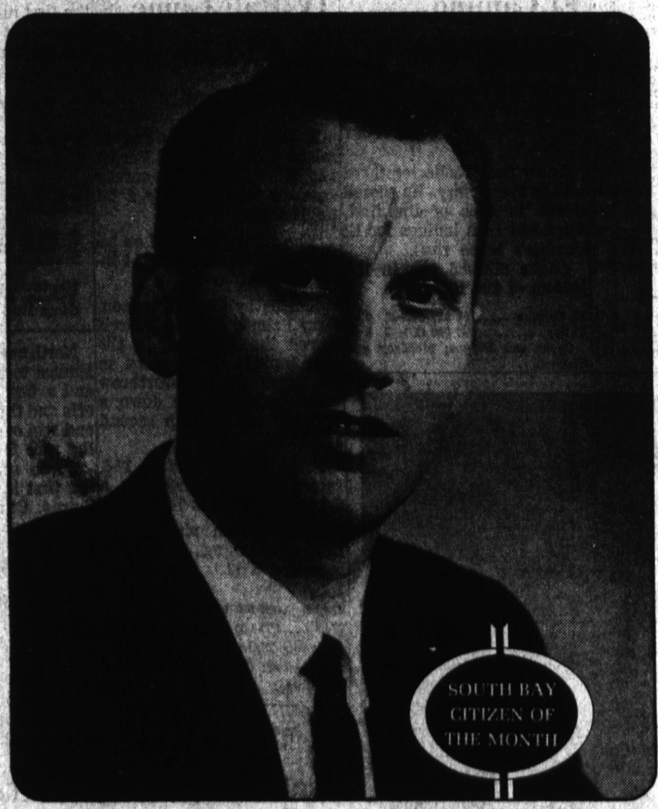
