To Benefit Legal Aid Fund

Palos Verdes Country Club has been chosen as the setting for the 12th Annual Counselors' Cotillion, Felice Fiesta, to be held the evening of June 1. The black tie, optional, affair is presented by South Bay Lawyers' Wives to benefit the South Bay Legal Aid.

Following many pre-parties which will be held in private homes, judges, lawyers, their wives and guests will gather for a gay social hour at Palos Verdes Country Club at 8 o'clock. Mrs. William Hollingsworth, social chairman, has planned interesting canapes.

At 9 o'clock, Gene Barrett's orchestra will herald dinner and dancing, according to Mrs. Thomas Foye, music chairman. Mrs. Richard Fox is dinner chairman.

Mrs. Byard Nilsson and Mrs. Theodore P. Shield and their committee supervise the transformation of the Country Club into a place of fiesta elegance. A multicolored canopy of ribbons and balloons will cover the dining room. Mrs. Robert Fredricks has coordinated the entire arrangements for this 12th Annual Counselors' Cotillion.

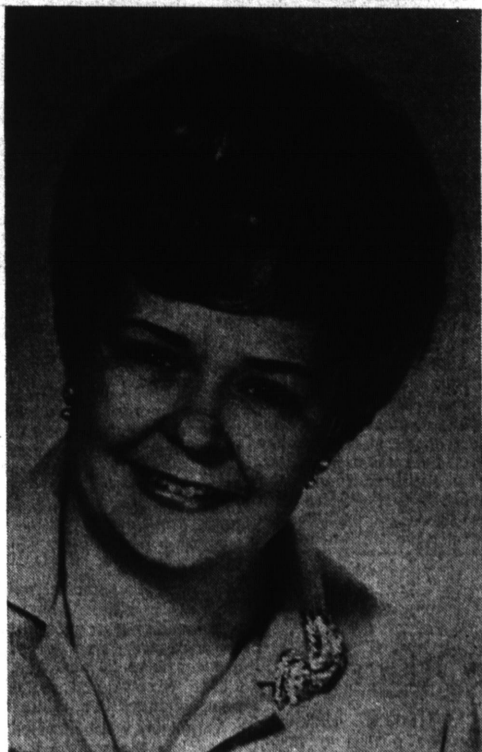
Fifteen years ago this method of assistance was formed by the attorneys of the South Bay Bar Association. Without funds, but aware of the mammoth need for legal assistance among low-income people in the South Bay area, Legal Aid opened its office in Torrance.

At the present time, the Legal Aid Foundation continues to operate without funds from any government source. The only charge to applicants for Legal Aid is a one dollar registration fee. The additional funds needed to pay the costs of operation are obtained through functions of the South Bay Bar Association. Proceeds from the Counselors' Cotillion is the primary source of revenue for this philanthropy.

An average of 110 desperate people in immediate need of legal assistance are helped in the average month. The Legal Aid office is open on Thursday and Saturday afternoons. Over 1500 applicants received help in 1967, all through funds derived from private functions, primarily, Counselors' Cotillion.

Through efforts of County Supervisor Burton Chace and his Field Deputy, Paul Moore, arrangements have been made for the moving of the Legal Aid facilities to the new County Courthouse in Torrance. This move will enable the Legal Aid program to take fuller advantage of the services of private attorneys and volunteer secretarial and clerical help. Thus, it will broaden the scope of its coverage of the disadvantaged in the South Bay area.

In line with this hoped for change, members of the Lawyers' Wives of the South Bay will broaden their scope of assistance and act at the new offices as secretaries and receptionists, and continue financial support through the annual Cotillion.

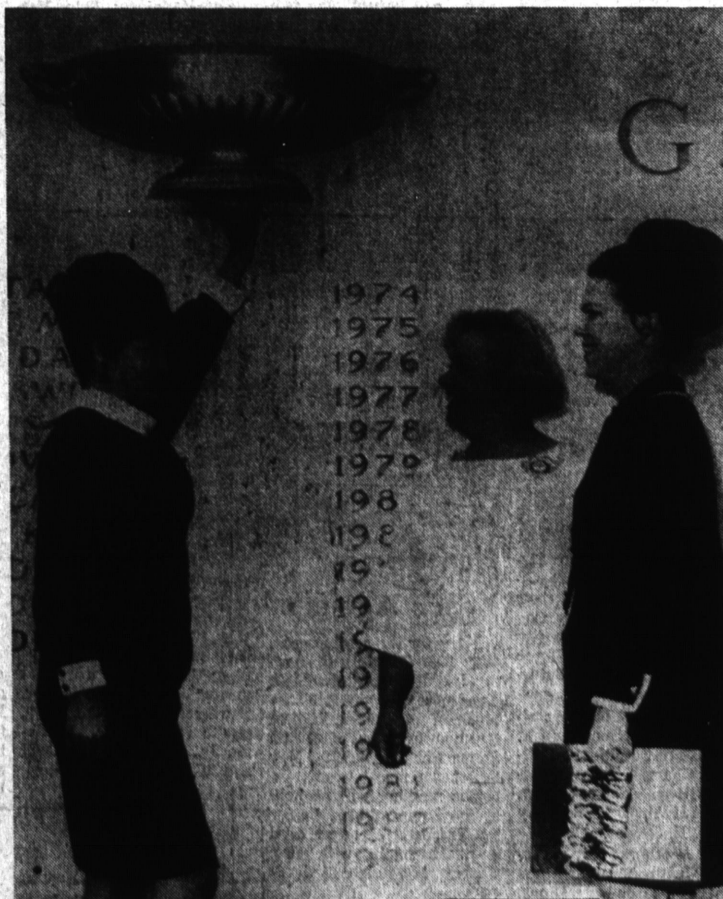
