He is survived by his widow, Janelle R. Skarda; two sons, Ronald and Donald, both of

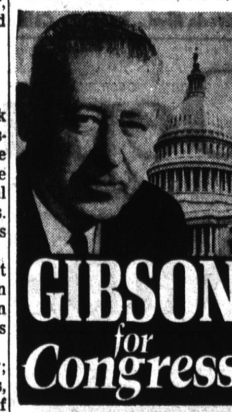

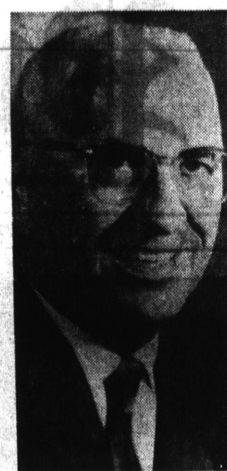

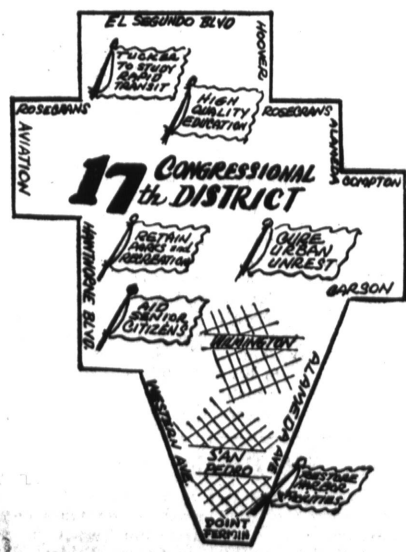
