


ARMED FORCES

Max N. Felker, founder and owner of Felker Manufacturing Co. here and operator of the firm until 1960, died Friday, June 14, after a year's illness. He had made his home in Rolling Hills for several years.

A native of Missouri, where he was born in 1908, Mr. Felker came to California when young and attended schools here, graduating from Redondo Union High School and the University of Southern California.

He began research in the industrial diamond tool area in 1924 and founded his own firm in 1936. His many inventions advanced the field of industrial diamonds throughout the world.

He retired from active participation in the business in 1960, selling the firm to the present owners. He had interests in a wide range of activity and devoted his time since 1960 to various enterprises.

Home Rule Advocates Win Round

SACRAMENTO—Advocates of home rule, or local control, gained Senate approval of a measure authored by Senator H. L. "Bill" Richardson (R-Arcadia) which would allow local governments to enact ordinances regulating many areas of conduct that now must gain prior state approval.

The legislation carries the support of the District Attorneys Association of California, the League of California Cities, the California Peace Officers Association and the County Supervisors Association, as well as many city councils and chambers of commerce from throughout the state.

"The more complex our California society becomes," said Richardson, "the more dependent we must be on home rule, not state rule. Home rule is a basic concept of our form of government."


