

A proposal to develop a cemetery along 213th Street near the San Diego Freeway which could accept 400,000 bodies in tiers of eight won unani-mous approval of the Board of Supervisors Tues-day, a vote which overturned the County Re-gional Planning Commission's denial. Developer Howard D, Martin agreed to accept 22 conditions proposed for the projected Carson Memorial Park.
