

day. Leland A. Doan, general manager of Dow's Western manager of the new facili-Division, said the new facili-ties will increase the plant's polystyrene production capac-ity to more than 100 million pounds per year.

Dow's Torrance plant is the largest producer of polysty-rene in the West. The materials are sold under the com-pany's Styron trademark and are used in the production of hundreds of products by the growing plastics industry in the West.

The Torrance plant was established in 1954 on a 54-acre site. In addition to producing Styron, the plant produces plastic construction and insulation materials.
