· Hearing On Budget **Scheduled**

A public hearing on a \$26.4 million school budget will be held tomorrow by the Torrance Board of Education.

The budget, as it is to be presented to the board, will call for expenditures of \$26, 451,573 and a total tax rate of slightly more than \$4.25 per \$100 assessed valuation. Dr. Frank Mattox, assistant

superintendent of schools for business, said nearly \$1.4 million will be used from the reserves to balance the spending program.

PRELIMINARY budgets submitted to the board called for a tax rate of \$4.37 per \$100 — an increase of about 12 cents over the cur-rent rate. The tax rate proposed in the final budget is expected to be about half a cent less than the current

Actual tax rates will be set by the county Board of Supervisors once the final budget has been adopted by the local trustees.

DR. MATTOX said total school district income is expected to be \$25,069,109.

Although some reserve funds will be used to balance the budget, the district will have some \$3.4 million in reserves left.

Carson Center Hit By Explosion, Fire

Damage Put at \$10,000

Fire swept through a Carson area shopping center early Thursday morning, destroying a laundry and damaging three other stores in the center.

Damage was estimated at more than \$100,000.

An explosion engulfed the laundry, located at 1159 W. Carson St., in flames. Cause of the explosion is still under investigation.

Flames were shooting out of the building when county firefighters arrived on the

THREE other stores were damaged by the flames. They include a barber shop, a beauty salon, and the Piza beauty saion, and the Piz-za Palace restaurant. The stores are located in the Carson Shopping Center, Normandie Avenue and Car-son Street.

The laundry is owned by Raymond E. Shore, 48, of 205 Via Los Miradores. It was totally destroyed. Damage to the laundry was estimated at \$70,000.

Capt. William Town of the County Fire Department said the alarm was delayed "The person who reported the fire didn't have a dime for a phone call and he couldn't find any place open at 1 a.m.," the captain said.

FIREMEN remained on the scene for nearly four hours after bringing the flames—which were visible to firefighters on the way to the location-under con-

trol.

Main concern of firefighters was to prevent the fire from spreading to the west and engulfing the W. T. Grants Co. store, Captain Town said. An aerial ladder was set up and officials (See FIRE, Page A-3)
