Concrete Barriers on Freeways May Increase Deaths, Hahn Says

It is a mistake to put a solid concrete centerline barrier on the Harbor Freeway, according to Supervisor Kenneth Hahn.

The supervisor outlined his objections specifically to the solid reinforced concrete barrier being installed from approximately Manchester Avenue to Rosecrans Boulevard on the Harbor Freeway.

HE WROTE John A. Legarra, State Highway Engineer, outlining his objections. "I do not know why the Highway Commission has spent hundreds of thousands of dollars removing the cable fence barrier on the freeway and putting in the solid reinforced concrete barrier," Hahn said.

Area Building Nears \$9 Million

Area cities, after a record breaking year of building activity in 1968, started 1969 with the same strength.

Figures for January indicated an almost \$6 million increase over January, 1968, statistics.

El Segundo jumped into the lead with an amazing \$7 million for the month followed by Torrance, the area's largest city with \$3 1/2 million. Redondo Beach was the only other city passing the \$1 million figure although Palos Verdes was just \$53,000 short.
