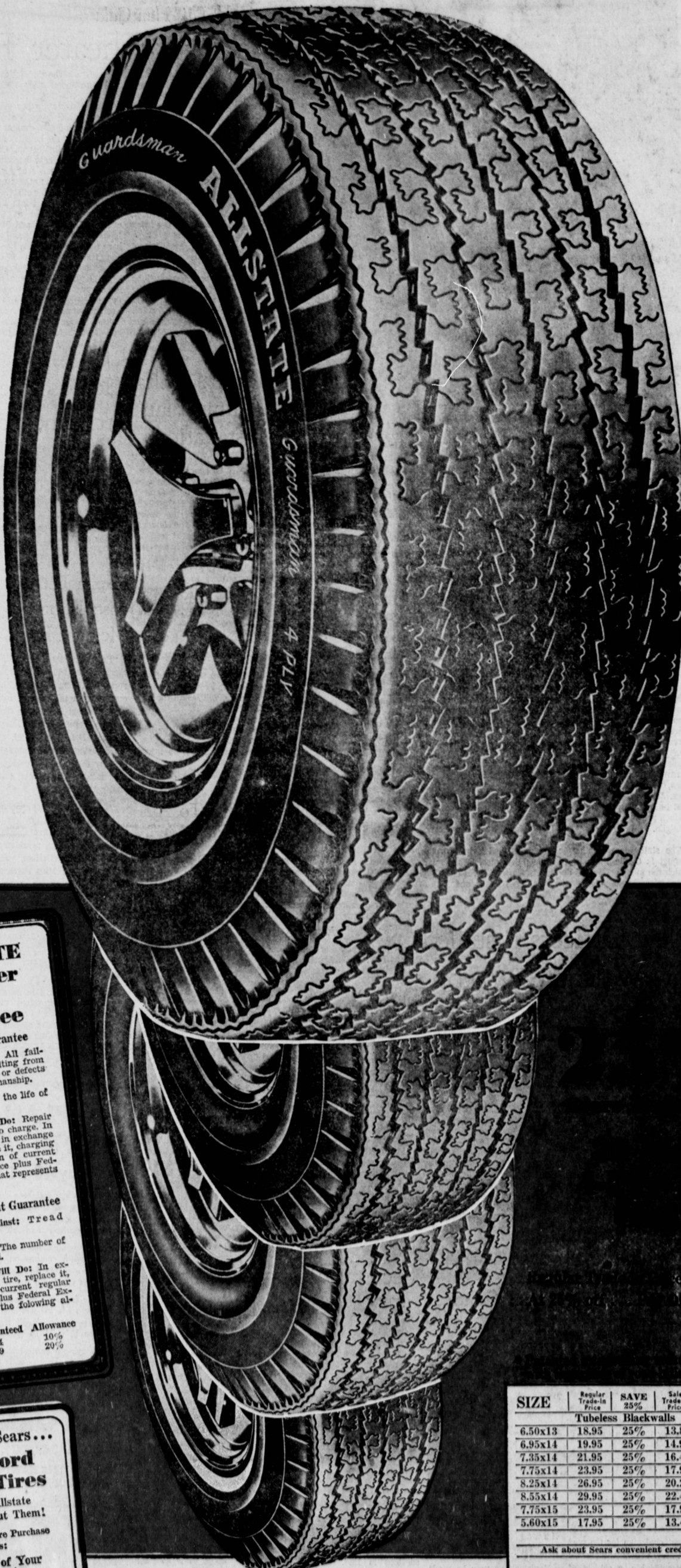
## Committee Chairman Appointed

## Taxpayers Ask IRS

### Postmaster Can Forward Refund

This column of questions and answers on federal tax matters is provided by the local office of the U.S. Internal Revenue Service and is published as a public service to taxpayers. The column answers questions most frequently asked by taxpayers.

I am moving next month and have not received my refund. Who should I give my new address to?

If your refund has not arrived by the time you move, give your postmaster your new address. Your refund can then be forwarded to you at the new address.

Thousands of refund checks are held up each year in IRS offices because taxpayers have moved without leaving forwarding addresses. When a check has been returned by the Post Office, it is held until the taxpayer either writes IRS or files another return giving his new address. The refund is then sent to the taxpayer or applied to any tax he may then owe.

I forgot one of my W-2 forms when I filed my joint return. Should I send it in now?

If you included the income and tax withholding data from the W-2 on the income tax return you filed, wait until you are contacted by IRS. You will be asked to supply the missing W-2 form.

However, if you did not include the wage and tax data from the W-2 on your return, then you should file Form 1040X, Amended U.S. Individual Income Tax Return. Fill out this form completely according to the instructions and send it with the W-2 to the Internal Revenue Service Center serving your district. Copies of Form 1040X are available at IRS offices.

Do you have anything that shows the filing deadlines for the taxes a small businessman has to pay?

Yes, IRS has a Tax Calendar and Check List for 1969. For a

free copy send a post card to your district office and ask for Publication 509.

My son won a savings bond as the best English student in his graduating class. Would the value of the bond be taxable income to him?

Whether the prize is taxable or not depends on the circumstances under which it was won. If your son had to perform a specific act to win the prize, such as write an essay or develop an experiment, the prize would be taxable.

A prize given in recognition of past accomplishments in religious, charitable, scientific, artistic, educational, literary, or civic fields is not taxable if the recipient is selected without action on his part and is not expected to render future services as a condition of receiving the award.
